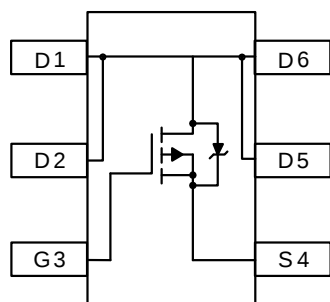

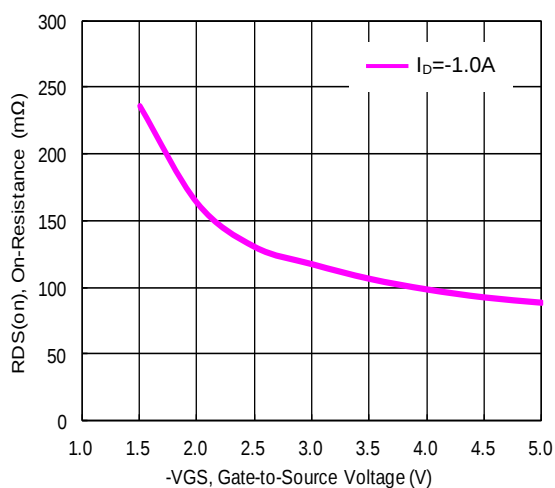
Typical Output Characteristics



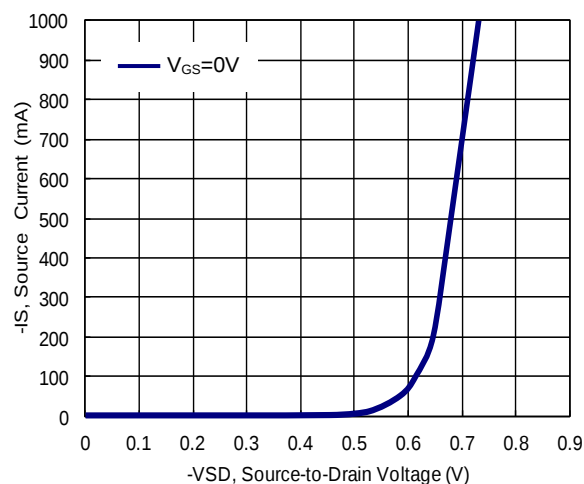
Typical Transfer Characteristics



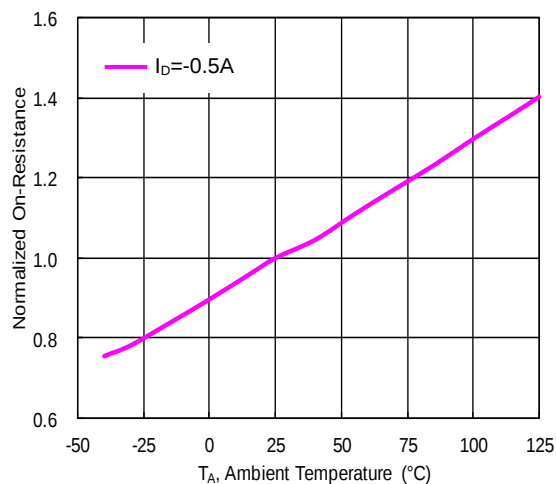
On-Resistance vs. Gate-to-Source Voltage



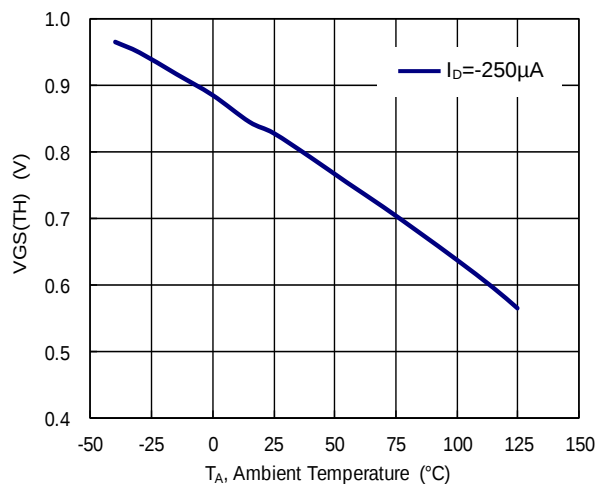
Diode Forward Voltage vs. Current



On-Resistance vs. Ambient Temperature



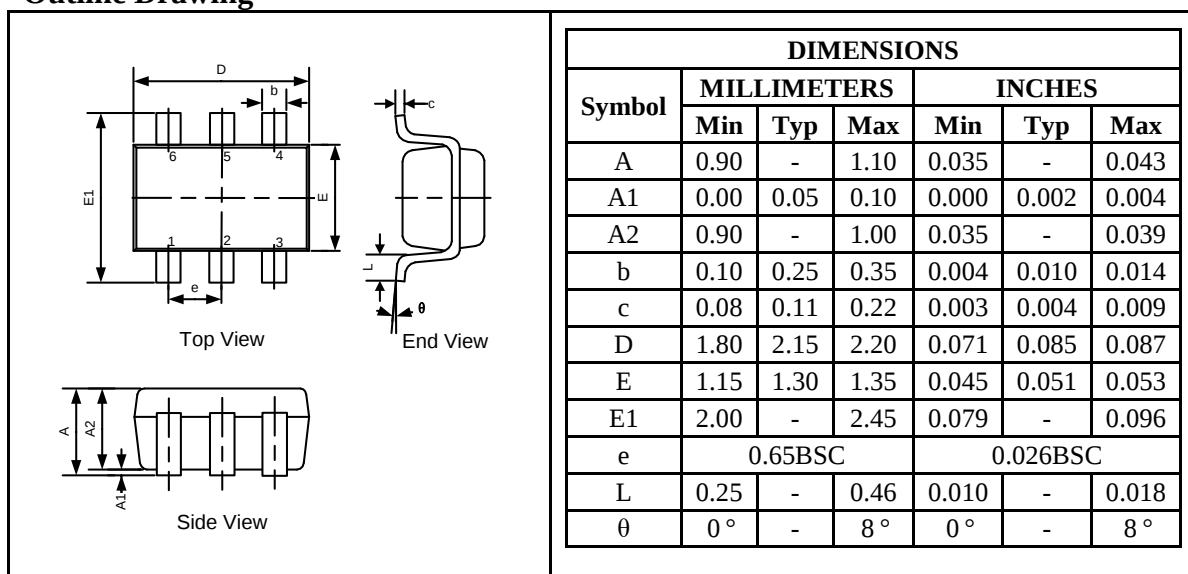
Threshold Voltage vs. Ambient Temperature



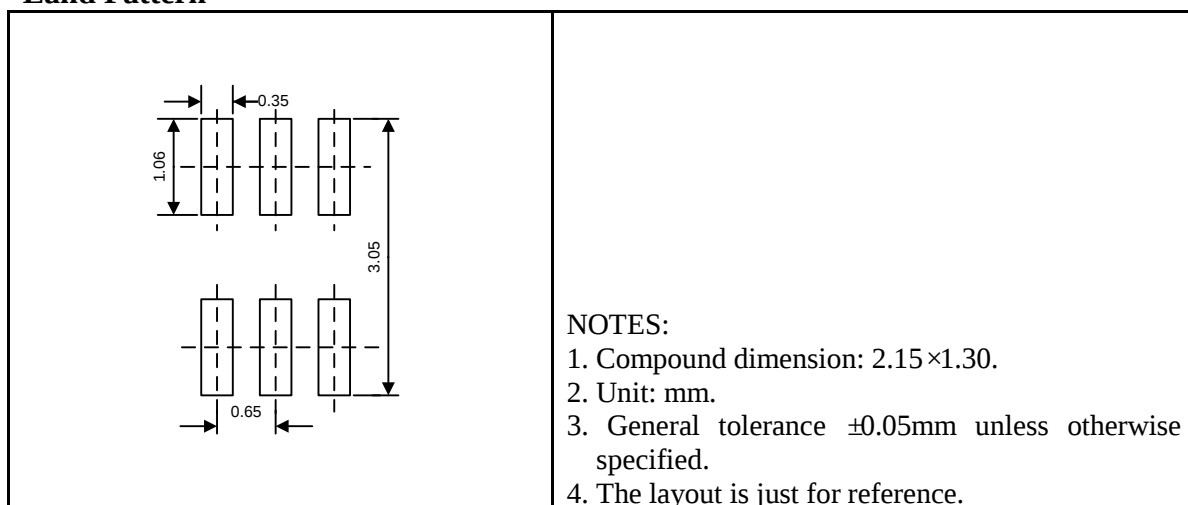

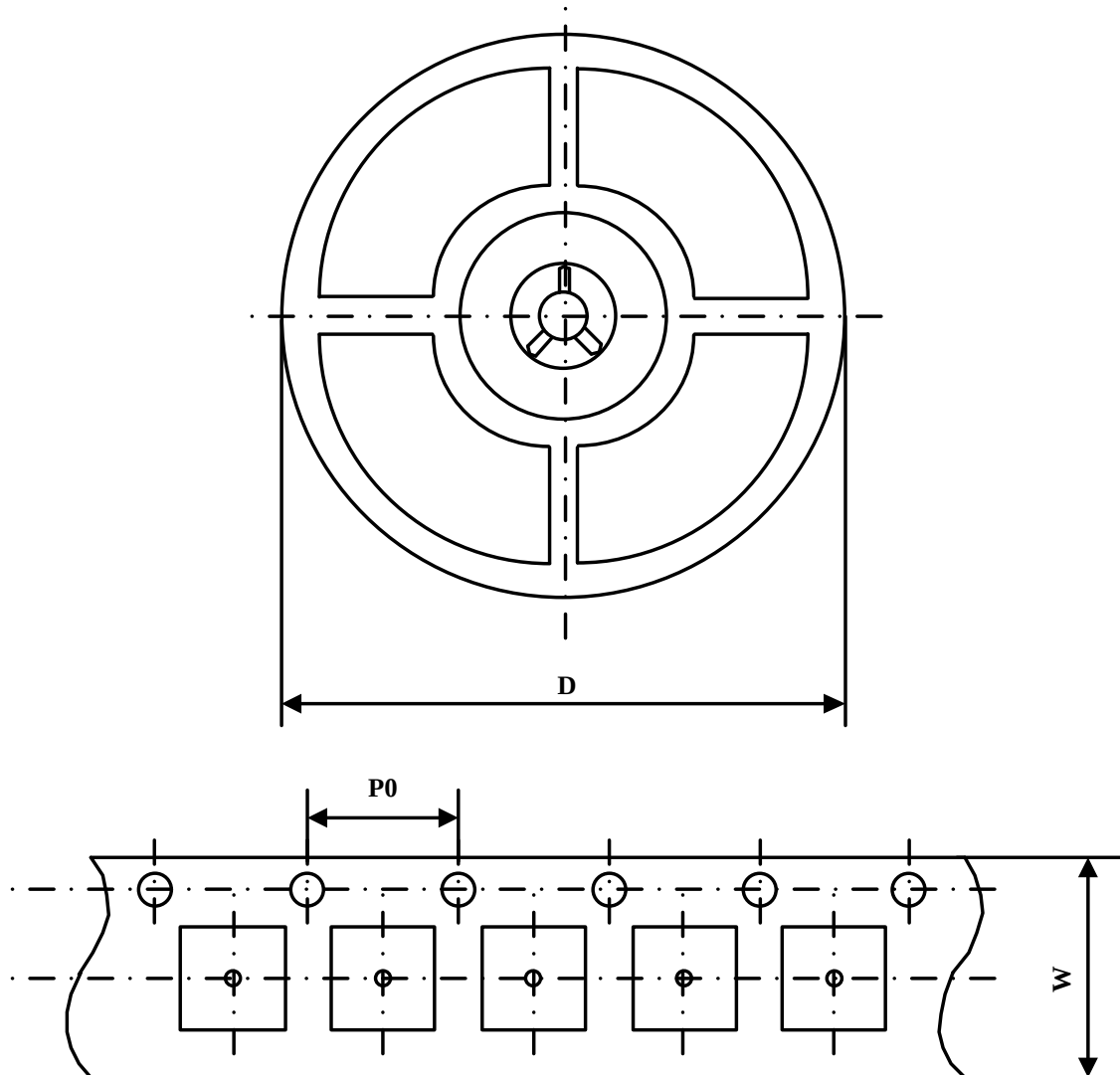
Land Pattern
